That the Adjoining Owners further release and quitclaim to Owner and its successor and assigns forever all right, title, and interest in and to the land lying between the fence wall and the _____ line as depicted on the survey attached hereto as in Exhibit B. That the true and correct boundary line between the properties is _____ feet to the _____ of the fence/ wall;

IT IS MUTUALLY AGREED AND COVENANTED that this agreement shall run with the land and be binding upon and inure to the benefit of the successors in interest of the parties and the parties agree to record same within the _____ County Clerk's Office.
